Bank's leverage ratio was 8.79% as of 31 March 2025, exceeded the minimum requirement. The increase of Bank's leverage ratio about 0.20% was mainly due to the increase from Capital by IDR 531bio offset with the increase of Bank's exposure by IDR 2.5tio from previous quarter
